## On March 12<sup>th</sup>

In 1948... NACA test pilot Herbert Henry Hoover becomes the first civilian to exceed the speed of sound when he flies the No. 2 Bell XS-1 to a speed of 703 mph (Mach 1.065).

In 1956... The first aircraft to exceed 1,000 mph (1,609 km/h) is an English Fairey Delta 2. Piloted by Lt. Cdr. Peter Twiss, it reaches a speed of 1,132 mph (1,822 km/h).

## Flight Rx by Dr. Pam Tarkington

### FAA's new regulation regarding DWI/drugs.

On the application for an FAA medical, item 18 asks about a history of arrests, conviction and administrative action regarding DWI/drug use. If yes is checked the applicant must provide the following on the explanation line.

1. the alcohol/drug offense and what happened as a result ( attendance of an educational or rehab program, license suspension, etc)
2. date of arrest, conviction and or administrative action

If the applicant has reported this before simply write: previously reported change. For all first time offenses the examiner must::

1. obtain a detailed history of the offense
2. obtain copies of all court records and arrest reports related to the offense.

This means that you will have to bring these copies to your exam. These records will be forwarded to the FAA.

It should be noted that even though you report this on your medical exam application, you are still responsible to report this directly to the FAA within 60 days of the occurrence of the arrest. The AME must defer if:

1. unable to obtain court records within 14 days of the exam
2. if the applicant has a blood alcohol of 0.15 or higher
3. if the applicant refused blood alcohol testing
4. if within the last two years there was another arrest, conviction or administrative action and there has been another arrest, conviction or administrative action at any other time
5. a total of three arrests, convictions or administrative action in a lifetime a total of two arrests, convictions or administrative action in the last 10 years.

If the AME defers, the FAA will need the following information from the pilot:

1. a detailed personal statement regarding his/her past and present alcohol/drug use
2. a complete copy of his/her current driving records in any state that he/she had a driver's license in the last 10 years.
3. copies of any court and arrest records pertaining to alcohol or drugs
4. an evaluation from and addictive psychologist/psychiatrist familiar with aviation standards

In this latest regulation by the FAA they go on to state "A single DWI arrest, or administrative action usually is not cause for denial provided are no other instances or indications of substance dependence abuse".
