My Grandpa Mirguet, on my mothers side, was immersed in aviation his entire life. During WWII, he was hired by the government to give flight instruction to new recruits in the Carolinas. After the war, he continued to work for his father (Mirguet Fur and Storage in Rochester) and flew from Rochester to Canada in his float and ski plane trading with trappers for animal pelts. He went on to fly for United Airlines. My Grandpa Mirguet had a big presence about him and was someone I looked up to immensely as a young adult.

When I first started flying myself, I trained out of the flight schools of Bill Law Aviation and AirVenture Aviation. Neither are in operation today. I flew the usual trainer type aircraft: 152s, 172s, Warriors and the like. I was immersed in my training and completed the private pilot program over the course of a summer.
